#### **RESEARCH INTERESTS**

I have over two decades of experience in survey methodology and gerontology-related research as Interim Director / Director of Survey Research at the University Center for Social and Urban Research (UCSUR) at the University of Pittsburgh. I have designed, directed and conducted statistical analyses on dozens of large-scale surveys of both general and targeted populations covering a broad range of social, clinical, and health topics. In addition to survey methodology and measurement, my research has focused on three areas: (1) the health effects of family caregiving; (2) the development and application of technologies that enhance functioning and promote independence in older individuals; and (3) elder abuse, including application of survey technology for collecting self-report data on abuse, racial/ethnic differences in the prevalence and experience of elder abuse, and susceptibility to financial exploitation.
